Statement from the Chair of the Trustees



The trustees have pleasure in presenting their report together with the financial statements for the year ended 31 March 2020.

Achievements and Performance

2020 Projects & Events

Refuge Council -Sharing Lives -Sharing Languages (ESOL)

Launched in April and originally called 'Pachedu Language Café', our ESOL support project was renamed 'Pachedu Sharing Lives Sharing Languages Project' after we successfully bid for funding from the EU's Asylum and Migration Integration Fund through the Scottish Refugee Council's 'Sharing Lives Sharing Languages' project. The project has engaged with unique individuals from migrant communities who have settled in Scotland from countries such as Togo, Ghana, Syria, Romania and Poland.

The group originally met in St. Ninian's Church Hall in Ferguslie Park, Paisley, but has since moved to Pachedu's new operational base in The Tannahill Centre, also in Ferguslie Park. PSLSLP's focus was very much on ESOL provision with a strong work and employability emphasis, based on needs assessment and feedback collected from participants in the first couple of weeks. However, more recently, the focus has shifted to more general English across all 4 main skills, although with most time spent on Reading and Speaking. This shift in focus has resulted from an increase in larger core group numbers, the now wider range of English language abilities and participants' own realisation that in order to continue improving their English and their confidence, they need to have a solid grasp of the basics as well as specific language and skills for more specialised contexts.

Feedback collected through questionnaires and interviews with participants and our Peer Education Volunteer (PEV) has so far been positive. Participants report feeling more confident with their English, while the PEV has commended the relaxed and informal atmosphere of weekly sessions which helps everyone to feel at ease and work together comfortably. In addition, participants have reported taking advantage of services offered by Invest in Renfrewshire and Skills Development Scotland as a result of information shared in PSLSLP sessions and their increased confidence in their English language ability.

Renfrewshire Council -Cultural Cafes

Another Pachedu project, Pachedu Cultural Café Project, was involved in planning and co-hosting a 'Burns Day Multicultural Food Festival'. During this session, participants learned about what was planned for the event and were given the opportunity to take part by preparing traditional foods to contribute. Participants were also told that they would have the opportunity to attend a free food hygiene training workshop and take a test which could see them awarded a basic food hygiene certificate, valid for one year.

Scottish Refuge -Refuge Week Celebrations

On 23rd June, Pachedu hosted an event at St. Ninian's Church Hall, Ferguslie Park, Paisley as part of the Scottish Refugee Council's Refugee Festival Scotland 2019. The event, entitled 'Positive Steps: Breaking Down Barriers', began with a video of a speech made by Takunda Muzondiwa at New Zealand's 2019 Race Unity Speech Awards. The Race Unity Speech Awards theme for 2019 was "Speaking for Justice, Working for Unity" and in her speech, Takunda, a child of the African diaspora, recounted her observations about the inherent racism of cultural assimilation and her own story of immigrating to New Zealand from Zimbabwe when she was seven years old. The video was used to spark discussion and encourage attendees to share their own experiences, as well as suggest actions that would contribute to breaking down barriers and promoting integration among different communities.

The event also included art activities and a bouncy castle for children, musical performances, dancing, food and drink. Over 60 people attended the event, and the response from attendees captured on comment/feedback post-its and posters was overwhelmingly positive, with requests for more similar events to be held in future.

2019 Organisational Development

Volunteer Co-ordinator & Project Lead

In addition to the Operations Manager, Pachedu has added another member to its Core Staff Team in the person of a Volunteer Co-ordinator & Project Lead who joined the charity as a volunteer in March and then became a part-time, salaried staff member in June. This new addition to the team is responsible for volunteer recruitment and co-ordination (support, training and management) and for leading our Sharing Lives Sharing Languages project.

Volunteer Recruitment

Pachedu has recruited 3 new regular volunteers to join the team in the latter part of the 2019. As mentioned previously, we now have a Peer Education Volunteer assisting with Pachedu Sharing Lives Sharing Language Project (PSLSLP) as well as a Volunteer Project Lead coordinating the School of African Culture project, and a new, young Youth Engagement/Youth Forum volunteer. This youth-focused volunteer position is particularly important to us to ensure that the voices and aspirations of young people from Renfrewshire's diverse minority communities are reflected in our projects and other wider work moving forward.

2019 Other Activities

The Diversity and Equality Alliance in Renfrewshire

DEAR is an initiative of Renfrewshire Council's Community Planning Partnership. It brings together equality groups from the Renfrewshire area to advise and contribute to the development and promotion of the current, emerging and evolving equalities agenda within the local authority area. The group aims to tackle inequality issues in constructive ways to positively change perspectives and promote more inclusive attitudes. We have attended DEAR group meetings throughout the year and actively contributed to discussions on the group's direction, mission, outcomes and activities. In 2020 Pachedu will work closely with other group members, namely University of West of Scotland and West of Scotland Regional Equality Council, on the planning of events, etc. to mark Black history Month in Renfrewshire

2019 Miscellaneous

Media coverage

Pachedu has been able to secure coverage of its activities through both local and national print and online media channels on at least 4 occasions over the last 6 months. The charity was spotlighted twice in articles in the *Paisley Daily Express* as a result of our Volunteer Coordinator speaking at Engage Renfrewshire's 'Celebration of Volunteers' event in June, then in another article in July reporting on our 'Positive Steps: Breaking Down Barriers' event as part of Scottish Refugee Council's Refugee Festival Scotland 2019. More recently, on 31st October, Pachedu was featured in an article in *The National* reporting on the launch of the Scottish Refugee Council's online interactive map offering "support, friends, information and advice" to New Scots as part of the EU-funded New Scots Integration project.

Social Media

With our Volunteer Co-ordinator also taking on responsibilityfor regular management and updating of our Facebook, Twitter and Instagram accounts, we have been able to increase the numbers of our followers across all 3 social media platforms, with new posts/Tweets at minimum on a weekly basis. This has allowed us to both showcase and promote our work, showcase and promote the work of partner organisations, increase engagement with new potential partners, supporters, volunteers, and to a lesser extent service users, while generally enhancing our profile and our reputation in the third/community sector locally, regionally and even nationally.

The Board was informed that effective 1st October 2019, Pachedu has moved its operational base from St. Ninian's Church Hall, Blackstoun Road, Ferguslie Park, Paisley PA3 1NR to The Tannahill Centre, 76 Blackstoun Road, Ferguslie Park, Paisley PA3 1NT. The Board was also asked for its approval to change Pachedu's registered address with OSCR to The Tannahill Centre, 76 Blackstoun Road, Ferguslie Park, Paisley PA3 1NT.

FINANCIAL REVIEW

Total receipts received during this year ended 31st March 2020 was £15,600 (£7,946 in 2019). Our main source of funding was a grant for sharing lives sharing languages (ESOL) FROM Scottish Refuge. Total payments were £11,509 which was spent on the charity's activities leaving a surplus for the year of £4,091

Risk Management

The trustees regularly review the risks to which the charity is exposed and do not consider there are any substantial monetary risks in the financial statements. However, the Board committed to undertaking a thorough risk assessment during the next financial period.

The trustees consider the charity faces reputational risk and continues to review processes and procedures to provide reasonable protection to mitigate this risk.

Reserves Policy

The Board aims to hold a minimum of three months of running costs in reserve in order to meet commitments and to cover any unexpected expenditure, which prudently equates to £1000. Total Unrestricted Funds held at 31st March 2020 were £373. The trustees believe that this is still an acceptable range but will continue to monitor the position.
